


[IGN-1053]	Email verification link takes to a blank page
[IGN-1099]	Session expired every time I reach the login page
[IGN-1121]	Switching back to my profile does not return data, the user needs to logout and login to review it
[IGN-1123]	Error on changing my profile (user is not logged out and token is not removed)
[IGN-1147]	Error message before CR submission to say which commodity has missing re-export information
[IGN-1170]	"Certifying Statement" for Re-export Certificates
[IGN-1173]	Commodity Gross Weight has a Zero default figure when left blank
